- Your ThinkSafe membership is licensed for a 12-month period.
- Your ThinkSafe membership is automatically renewed every year with an invoice sent out 21 days prior to the due date. The ThinkSafe Health and Safety System is payable in full upon receipt of your ThinkSafe pack. Postage and packaging is payable by the customer. Please note the Customer agrees that full payment is due on the due date for all products and or services delivered to the purchaser by ThinkSafe. Any expenses, disbursements and legal costs incurred by ThinkSafe in the enforcement of any rights contained in these terms shall be paid by the Customer, including any actual solicitor's fees or debt collection agency fees.
- If you don't wish to renew your membership, ThinkSafe must be notified in writing at least seven days before renewal date. Your license to use ThinkSafe material will expire forthwith and continued use is a breach of copyright and prohibited. **If you fail to properly notify your cancellation of membership in a timely manner, and your pack has been dispatched, your renewal for the ensuing year will be legally binding. You have entered into an annual renewable contract with ThinkSafe that has been heavily discounted in Year 1. If you choose not to renew membership after the first year, there is a 'Break Fee' of \$200 + GST. No 'Break Fee' will apply after Year 2.**
- ThinkSafe licensed membership is for NZ business entities only.
